- 6) Recorded field closing announcements for Department of Parks and Recreation (DPR) Park Sites only will be made by 3:00 PM on weekdays and by 7:00 AM on weekends and holidays. When necessary, recorded messages will be updated on weekends and holidays at 12 noon. DPR staff may make updated field closing decisions on site, at any time weather/field conditions are deemed unsafe for play.

Activity Level	Scope of activity permitted during each phase. Team Competition is limited to park sites only in Phase 3.
Participation	Total number of individuals authorized to gather on a field.
Permits	Field permits to be issued by Sports Services in accordance with the above guidelines and PWC policies.
Field Division	Groups are permitted to sub-divide fields into halves under Phase 1 guidelines. Division of fields under Phases 2 & 3 is conditional upon meeting the appropriate social distancing requirements among the number of participants on-site.
Social Distancing	Recreational sports may occur if ten feet of physical distance can be maintained by all instructors, participants and spectators. Phase three social distancing is conditional pending input from VA Governor and PWC Executive Management.
Physical Contact	Competition that involves close contact with other athletes must be avoided. Incidental contact or contact between members of the same household is acceptable. Phase three contact is conditional pending additional guidance.
Spectators	Spectators should remain off the field of play and practicing social distancing guidelines.
Concessions	Concessions are limited to pre-packaged items only in phases two and three.
Restrooms	Fixed restroom access is expected to be available in phase two, where applicable. Portable restrooms are expected to be available and returned to normal cleaning schedules in Phase One.
League Buildings	League buildings are again accessible. Leagues must look to implement the appropriate cleaning and disinfection procedures before and after use. It's recommended leagues limit access to these buildings.
Tournaments	Baseball and Softball Tournament play may resume during phase three provided the tournament organizers submit a detailed operations plan indicating what safeguards are being put in-place in observance of these guidelines.
Special Events	Special Event approval is conditional in phase three only pending review and approval by PWC Assistant Director of Recreation and Chief Park Ranger.
Grounds Services	Requests for additional field services are contingent on available staffing and resources.
Amenities	All amenities, such as dugouts and bleachers, must be cleaned and disinfected before and after use by the permitted groups.
Equipment	There is no sharing of equipment in phase one. Equipment sharing is conditional in phases two and three as all shared items must be disinfected between each use to the extent practicable.
Signage	Groups will be required to post information on their website providing public health reminders about social distancing, gatherings, options for high risk individuals and staying home if sick. DPRT will review signage options at park facilities.
PPE Masks	The use of masks is recommended by community use groups to the extent practicable.
COVID-19 Acknowledgment	Groups must alert all participants and/or guardians of the inherent risks of sports participation as it relates specifically to COVID-19 via a written form of acknowledgement.
COVID-19 Response Plan	Groups must have a response plan in-place to anyone experiencing symptoms and/or has been exposed to COVID-19 to include, but not limited to, transportation to their home or health care facility.
COVID-19 Screening	Groups must conduct daily screenings of coaches, officials, staff and players of COVID-19 symptoms prior to admission. Screening should be conducted in accordance with applicable privacy and confidentiality laws. Screening may be completed by parents and/or via verbal confirmation with adults upon arrival. It's highly recommended that screening occur periodically by coaches throughout the course of the activity/event in all three phases.
